The President presides at all state meetings, and appoints committees. The Vice President is a backup for the President, is a voting member of the Legislative Committee and assists District VPs. The Secretary retains all records and minutes. The Treasurer collects dues and other receipts, pays all bills, and supplies financial statements at periodic intervals. The Treasurer is bonded.

Legislative Recap and other good things to know

HB1222 Residential RE Service Agreement (effective 3-14-24)

Protects homeowners from the predatory practice known as Non-Title Recorded Agreements for Personal Services (NTRAPS). Recorders are held harmless if they do record one after this time.

IC 32-17-14-11, IC 32-17-14-13 Quitclaim Deed with TOD Deed (effective 7-1-24)

- 1. It must be recorded in the Recorder's Office before the owner's death...Section 13 (e)
- 2. Example language ("(insert owner's name) conveys and warrants (or quitclaims) to (insert owner's name), TOD to (insert beneficiary's name)." Section 11(f), Section 13(d)
- 3. Auditor must endorse either type: Section 11(i), Section 13(g). Not previously required for Section 11.

Recording Order is Important - The majority of what we do is by code/law. See IC 36-2-11-8 (a) for why the recording order is important.

Life Estate reserved by Deed

After life estate holder (Party 1) dies, affidavit is recorded reflecting the automatic transfer to Party 2 which merges life estate into remainder. Index as Party 1 with "type/code" as Life Estate on Party 1.

Trust on a TODD – Don't recommend on-the-spot corrections to TOD Deed

Each grantee listed as an owner in a Transfer on Death deed must be an individual (natural person) who is certain to eventually die.

There are two main formats that can be used to identify the Owner in a TOD deed, so that the Owner's death causes the property to pass to the TOD beneficiary(ies).

Shorter: Olivia Owner (Grantor) CONVEYS AND WARRANTS on Grantor's death to _____ (TOD beneficiary)

Longer: Olivia Owner (Grantor) CONVEYS AND WARRANTS to Olivia Owner

(Grantee), TOD on Grantee's death to _____ (TOD beneficiary)

Use of the shorter format can create a potential trap and make the TOD deed invalid if the current Owner and Grantor is not an individual (natural person). For example, if the record owner is a trust. A trust can be a TOD beneficiary, but a trust cannot be an Owner.

DO NOT RECOMMEND THE SUBMITTER MAKE HANDWRITTEN CHANGES! Recommend they contact an attorney to investigate and to revise the deed.

IC 36-2-11-2.5 (g)

Elected Recorders must certify completion of the requirements in subsection (b) every year and file the certification with the SBOA in the same manner as the report required in IC 5-11-1-4(a).

Why index the notary?

Notaries could use it to check that there are not documents being recorded as notarized by them without their knowledge.

Should this field be searchable by public or just an internal field? The field would need to be separate so that a notary name wouldn't display for every document they notarize every time they have a title search done.

Can we have an alert system available connected to this indexing field similar to Property Watch or Property Fraud Alert?

From PRIA Indexing Work Group:

- Assists law enforcement with fraud cases by identifying notary on document.
- Assists authorities in identifying notary impersonators.



Legislation around the country

Ohio is working on legislation to protect veterans being targeted by outside businesses to pay for their DD-214s. Go <u>HERE</u> for more.

Just fyi...Some states have legislation in place to require people submitting documents for recording, especially (or only) conveyance documents, to show ID first. Indiana does not, and we should not ask for it without legislation to back it up except as required for DD-214s. Wholesalers "buy houses for cash," record a purchase and sale agreement, while never actually owning the property. Document doesn't need the buyer's signature. It can be called "Memorandum of Contract," "Intention to Purchase," or something similar. It involves entering into a contract with a seller and then transferring the right to purchase the property to an investor for a higher price. Wholesalers make a profit from the price difference. Wholesaling laws vary from state to state. See IC 32–21. Read this *Forbes* article.

As far as county government, I have only worked in the Recorder's Office since Feb. of 2012 – 12 years. And I have only lived in Clinton County.


My dream vacation would be Hawaii. Sweet or salty snacks? Sweet - I love chocolate!


Beth Keeney, Clinton County Recorder, WC

Interesting Facts

Orange County

- Home of West Baden Springs built in 1855, initially called Mile Lick. Rebuilt in 1902.
- French Lick established in 1857, became known for its health resort founded around 1845.
- Orleans: Founded in 1815, it is the oldest town in the county. It was named after General Andrew Jackson's victory at New Orleans.

St. Joseph County

- 1882 First electric trolley streetcar system in the United States!
- Home to Notre Dame, founded November 1842.
- Named after the St. Joseph River, which flows through the county. The river itself is named after Joseph, the husband of St. Mary, the mother of Jesus

Clinton County

- Founded 1830, named for New York Governor DeWitt Clinton, who had been involved in building the Wabash and Erie Canal.
- General James F. Record was born and raised in Clinton County. He was awarded three Distinguished Service Crosses for his gallantry during the Vietnam War.

Huntington County

- Named after Samuel Huntington, who signed the Declaration of Independence and the Articles of Confederation.
- Warren hosts the museum collection in honor of The U.S.S. Salamonie, AO-26, Cimarron Class Fleet Oiler from World War II and is also the location of Heritage Pointe.

Wayne County

- Formed in 1811. It was named for General "Mad" Anthony Wayne, who was an officer during the Revolutionary War.
- Johnny Ringo, a famous outlaw who became the chief antagonist of Wyatt Earp, was born in Greens Fork, Indiana (then known as Washington).

Dearborn County

- Formed in 1803 from a portion of Hamilton County, Ohio.
- Named after Dr. Henry Dearborn, who served as an officer in the Revolutionary War and the War of 1812.
- From 1836 to 1843 the Whitewater Canal was built through Dearborn County. River and canal trade dominated the county's commerce until the construction of the Ohio and Mississippi Railroad in the 1850's.

Interview with Jana Gray, Morgan County Recorder

In 2022, the Morgan County Recorder's Office was listed as a respondent on a UCC filing as was Jana Gray, Morgan County Recorder, as an individual. The County Auditor, the bank, the title company and multiple other parties were also listed on the UCC. The filer alleged an indebtedness of \$6,000,000.00! The (then) Morgan County Attorney sent a letter requesting the filer release the UCC citing it's fraudulent recording for lack of notification to the Recorder and Auditor as respondents and, for citing them at all in their status as individuals. Matthew Whitman filed the UCC on 06/29/2022, approximately a month (05/31/2022) after a mortgage foreclosure was filed against him & Maci Whitman 55C01-2205-MF-000835. Mr. Whitman would not release the lien, so the County sued Mr. Whitman 55C01-2207-PL-001160.


Morgan County ultimately won, and the outcome is documented in the court order signed/dated 09/25/2023. The case took over a year to conclude which isn't unusual in the civil court cases. Jana didn't have to attend most of the hearings, etc., but was able to attend the concluding hearing via Zoom. She observed at the zoom hearing the Judge asked Mr. Whitman if he was attending from a jail cell and he answered he was. I was glad Jana told me that it was not a stressful experience. "It worked out," and added, "hopefully this will help newer Recorders realize this type of thing just 'goes with the territory' when you are an elected official and not to stress out about it." I won't tell her age, but Jana is in her second term and will probably retire/semi-retire at the end of it. She is a veteran of County Government, having started part-time in 1996. Asked if she likes the job, "Oh, yeah," was her quick reply. Thank you, Jana, for sharing your story.

Editor's Note: Jana and I pondered that frequent rhetorical question I'm sure we have all mulled over... "Why do people blame others for their mistakes?" As public officials, being named in a lawsuit is something many of us have or will have to contend with as part of engaging with the public. You should know that in the event you are sued, your county is there to support you. When we are performing our duties in the capacity as an elected official, we are protected by statute. My experience as Clerk was that sometimes the County Attorney handles the case, but in special situations the Commissioners will approve outside counsel. It isn't uncommon that the cost of billable hours or the case load make it impractical for the County Attorney to take the case. Also, the situation may justify use of an attorney with experience in a particular area.

Have you been sued in your capacity as Recorder? What's your story? Your shared experience could be helpful to a fellow Indiana County Recorder.
